 - 5) Cannot refer to the immune system
 - 6) **Cannot refer to pain**
 - 7) Cannot refer to any unwell state

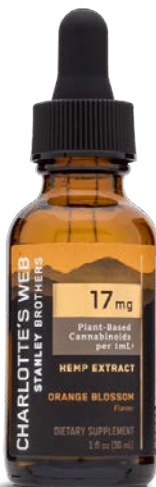

- **Use compliant terminology like:**

 - 2) Designed to help you keep doing what you love
 - 3) Made to support you, day-to-day, moment-to-moment
 - 4) Designed to support your daily passion for a better you
 - 5) Free of 8 major allergens, no animal testing, gluten-free, vegan

- Do not use “skin health” (medical); have to stay in the “nourish and moisturize the skin” lane
- Use the term “all-natural” sparingly if at all as it means very little, is overused, and can be confusing in the marketplace
- The new cream is not being marketed as a scented cream, but is not labeled “unscented” because it does have a hempy scent to it

 - 2) Use of any disease name or reference to a disease
 - 3) Any express or implied comparison to drugs
